

Applying to Become an Adjudicator for MSBOA JAZZ ENSEMBLE Festivals

Information

The Michigan School Band and Orchestra Association seeks highly qualified music educators to serve as adjudicators for our festivals. Evaluation of our students and ensembles holds a very high position of importance in the mission of the MSBOA. We consider the qualifications of each candidate very carefully. Candidates must have a minimum of 5 successful years of teaching instrumental music at a high level of achievement (10 years preferred).

The Process

Candidates may take this workshop without initially receiving MSBOA Executive Board approval – **with the understanding their application may not be approved by the Board and they would not be placed on the Adjudicator List.** Persons interested in becoming an adjudicator for MSBOA's Jazz Festival must apply to the Association using the application found at the end of this document. Candidates must attend the Adjudicator Workshop held in November in its entirety.

This application is reviewed by the District Executive Board that has jurisdiction over the applicant's home. Each District renders a decision, either approving or not approving the candidate. Those recommendations are submitted to the full MSBOA Executive Board for a final decision. The full Executive Board will decide on each candidate individually and may or may not agree with the District's decision.

Timeline

- **October 2, 2023** – Deadline for the submission of applications to the State Office. Be sure to have two (2) signatures of support and include the required paragraph with your submission.
- **October** – Applications reviewed by District Executive Board
- **November 10, 2023** – Jazz Ensemble Adjudicator Workshop @ the MSBOA State Office, Okemos, MI (More info to follow on specific schedule, but it would be safe to carve out from 8:00 a.m. – 5:00 p.m.)
- **November 10, 2023 (evening)** – Applications reviewed by State Executive board
- **The week of November 13** – Candidates informed as to whether or not they have been accepted as a Probationary Jazz Adjudicator

Approved candidates must attend the workshop in its entirety to be placed on the Probationary List.
